**Objective 1.** Train 50 Voter Registration Agents in Santa Fe County to facilitate greater voter integrity and 10% more Republican voters by 2022.

### Activities:

- \*Host class for 25 residents at SFFRW event by end of 1st quarter 2021
- \*Host class for 25 residents by Q3 2021

**Objective 2.** Meet with County Clerk to discuss E and VI complaints from 2020.

### Activities:

- \*Seek and record a list of complaints by end of 1st quarter 2021
- \*Meet with County Clerk by end of Q2 2021

**Objective 3.** Educate ourselves on state election law and county policies and guidance.

### Activities:

- \*Invite the Santa Fe County Clerk to speak to SFFRW members on election and voter integrity in Q2 2021
- \*Invite the Santa Fe County Clerk's Director of the Office of Elections and Voting to speak to SFFRW members in Q2 2021

**Objective 4.** Educate ourselves on the RPNM training for poll challengers and judges to turn out 150 poll challengers and judges for upcoming elections.

### Activities:

- \*Train at least 3 Santa Fe County voters as trainers on RPNM election and voter integrity for poll challengers and judges by Q3 2021
- \*Train 50 poll challengers by Q2 2021 in SFC and assign them to precincts or polling locations
- \*Train another 100 poll challengers by Q2 2022 in SFC and assign them to precincts or polling locations

## PRESIDENT'S MESSAGE

Dear Members,

It's sad to see them lined up like silver sardines. They are not sardines, but kids wrapped in those shiny shock resistant survival blankets. The news says there were 650 kids a day last month. The U.S. Customs and Border Patrol says that is up from 313 per day in February 2021, and an average of 208 per day throughout 2019. We normalize the children when we call them UACs (unaccompanied alien children). The US Department of Health and Human Services is running out of room and turning to FEMA for help. Soon the UACs will be shipped all over the country to a federal military facility as Obama did in 2014 during that surge of UACs. Last week there was a plan to bring a few thousand to Santa Fe County. Under President Obama's masterful plan UACs rose from 38,759 in 2013 to 68,451 in 2014. President Biden is on track to yield a quarter of a million children this year. Why do they come? How exactly does a 10 year old show up at the U.S. border? They are coming to our border now because they heard President Biden, on the campaign trail, say that the gate is open. President Biden cancelled the Remain in Mexico agreement with President Trump and the gates opened. So parents sent their kids with the cartel's coyotes and \$7,000 to get to the U.S. border. What's missing from the discussion over Biden's illegal immigration policy discussion is the fact that another 600,000 non-USA citizens overstay their VISAS and become illegal immigrants lost in the system. Non-US citizens enter American every year with specific permits to visit on VISAS as students, businessmen, and vacationers. VISAS have dates that specify when they are to leave the country. According to the U.S. Department of Homeland Security FY19 Overstay Report, 676,400 didn't leave the country when the permit expired that year. At the end of 2020, 12 months later, the number shrunk to about 500,000. And that's just one year. Year after year the number of non-US citizens in our country grows and grows. Is it serious? Yes. Is it urgent? Yes. The 9-11 terrorists overstayed their student VISAS in 2001 before they executed their plan to kill thousands of Americans, ultimately killing about 3000 Americans. I'm afraid the Biden Administration isn't interested in who is coming or staying in our country and what their intentions are. The catch and release game is back and it works. Welcome to America.

## Fear and the Freedom to Speak

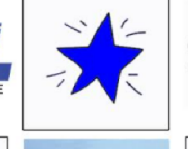
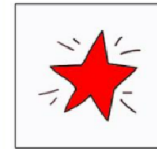
Benjamin Franklin said, "Whoever would overthrow the liberty of a nation must begin by subduing the freeness of speech."

Social media, despite its virtue of connection, progressively indoctrinates its users into a matrix of narrow ideas rather than encourage discussion among varied points of view. The recent banning of many conservatives from Twitter and the curtailment of the alternative social media platform Parler by Google, Amazon, and Apple shows just how far the social media giants wish to control the narrative. To the same end, the legacy media has taken great liberty with our perception of the world by prescribing what to think and how to think about it. Regardless of individual political leanings, this institutionalized conformity should concern every free citizen. It is a form of population control that requires no physical force or overt pressure, just a continual manipulation of information -- something most remain largely oblivious of. A recent Gallup poll found that 33% of Americans have no confidence at all in the media. This is an all-time high that reflects the overt partnership that has come to characterize corporate media.

In such a climate, it's imperative we stick to our conscience and convictions to form our own perceptions and not be led by the nose to conform to opinions not our own. Open and uncomfortable conversations are absolutely necessary to navigate the many contentious issues of today, and media providers who refuse to engage on those terms should not be granted the authority to make decisions on our behalf. They have betrayed the trust of their positions. Free speech must be protected and fortified by individuals willing to take their place in the battle of ideas and not succumb to fear, denial, or ignorance. Otherwise, the masses will become lemmings headed toward the cliff of bad ideas, egged on by media propaganda that absolves them of independent thought.

## Update on Election Integrity

In January 2021 your board of directors decided that election integrity would be one of our two priorities this year.  
Election integrity and voter integrity are terms we hear every day, but finding the definition for these terms is  
difficult because they are still being debated by lawyers around the country. At a minimum voter integrity includes  
preventing voters from voting twice or voting for others. Election integrity includes prohibiting ballot harvesting  
and prohibiting election watchers from watching the counting of all votes. These are activities that many New  
Mexicans believe happened in the 2020 election. Legal challenges are still in the process. The SFFRW has developed  
the project on the next page to better understand and act on election and voter integrity concerns going forward.  
The project will be amended as more is learned.  
Goal: Educate the Republican voters of Santa Fe County to help minimize activities that are inconsistent with the  
existing state law and local policies and guidance during the 2021 and 2022 elections to achieve a reliable election  
process and result.



## Scholarship Contest

One of the missions of the SFFRW is to push forward traditional New Mexico  
values of faith, family, and freedom. To that end our organization has established  
a \$1,000.00 scholarship to be awarded to a high school senior residing in Santa  
Fe County, who will be entering college in the Fall of 2021.

Eligible students are asked to submit an essay based on a quote from George

- \* Explain the meaning the quote has to he/she personally in terms of faith,  
family, and freedom
