# *Message from the President*

Dear friends,

The survival of critical infrastructure that supports modern life starts with reliable energy. We must be the ones to call out the policies and the lies being told.

I was there at the new Department of Homeland Security when it opened its doors after 9-11 in 2003. My team was asked to consult with a lot of other smart people to develop a Critical Infrastructure Program for the 16 critical sectors in the U.S. (see <https://www.cisa.gov/critical-infrastructure-sectors>). Sandia Lab was hired to model the interdependencies of the critical sectors.

At the top of the list was and still is ENERGY. Without it, the other 15 infrastructures that we rely on for modern life fail. There is no excuse for advanced countries like those below to experience a shortage of electricity or other types of power or severe inflation of energy costs. But failing we are.

How many examples do we need to change our course?

Example 1: Remember last winter when California was forced into rolling brownouts in its quest for zero-carbon power ahead of other states? They were only at 27% of meeting their renewables goal, and the electric grid couldn't function. You see, the grid wasn't designed for intermittent energy flows like wind and solar.

Example 2: On August 26th the California Air Resources Board adopted new regulations effectively banning the sale of gas engine vehicles by 2035. 17 states have tied themselves to California's emission standards and New Mexico is one of them. Four days later Governor Newsom declared a state of emergency due to excessive heat and the electric grid. The Governor is urging residents and businesses to reduce use of electricity to avoid additional power outages by not plugging in cars and major appliances between 4pm-9pm! Experts say that reductions in energy supply are a direct result of California energy policy making the grid unreliable by mandating renewables. How is it that government can require everyone to have electric cars in 10 years even though we can't even plug them in today. (ABCNews.go.com)

Example 3: Look at the disaster that is befalling UK and the rest of Europe. The UK is announcing that energy could be rationed for years ([Powerlineblog.com/archives/2022/08](https://www.powerlineblog.com/archives/2022/08)). Why? Gas prices for the UK are more than 16 times higher than the average prices over the previous decade. Household bills for wholesale gas and power are due to increase by 80% a year from now, even though the UK has large potential supplies of oil and gas. Countries like the UK and Germany are facing failure because they needlessly failed to provide for their own energy reliability and self-sufficiency. And, the Biden administration is following the same path.

Example 4: France is a little better off because its electricity has come from its own fleet of nuclear power plants. It has generated 70 percent of its electricity from a fleet of 56 reactors, but 32 are now offline. The French PM says companies may face energy rationing this winter. The government is working on a quota trading system where businesses can buy and sell electricity to each other. PM Macron says the "the months ahead are just a step in the bigger transition that we need to make." Boy, does that sound familiar.

Example 5: Germany's impending disaster is one of its own making too, but with more variables. Angela Merkel announced her nation would close all its nuclear power plants after the Fukushima disaster in 2011, at the same time quadrupling down on the decarbonization of its economy. In so doing, Germany is left with relying more heavily on Russian natural gas. Meanwhile, Putin is demanding EU nations pay for energy in Rubbles, undercutting the European economy on a whim. Germany now has the highest global electricity prices per household in the world, at 5 times more than last year. To reduce the cost of electricity, the German government announced it will subsidize the use of more coal-fired power plants. Germany began its transition to green renewables 30 years ago, and now they are begrudgingly returning to fossil fuels-- it claims temporarily. This situation of declining supply and radically higher costs is facing the US, too. Could you pay a utility bill every month that is 5 times more than last year?

Example 6: Meanwhile China and India build a new fossil fuel plant every month to fuel their economy at our expense. The elite left yearn for a utopian future and doesn't care about the costs faced by us - its citizens in the US and Europe. We saw it last month: gas prices rose to \$7/gallon in California and Biden said it's just part of the transition. Meanwhile, the energy independence and system reliability we enjoyed here in the US just two years ago slips away and costs continue to rise. Failing we are.

Many of you are aware that over the course of several years more of our constitutionally protected rights have been abused, violated, ignored, or taken away from us. The right to private property is being attacked now. The V and XIV amendments were established to protect this right. We must fight to retain it. As John Adams said, "Property must be secured, or liberty cannot exist."

On January 27, 2022, President Biden signed Executive Order (EO) 14008, tackling the Climate Crisis at Home and abroad. The EO declares that the top priority of the Biden's foreign and domestic policy is to address the climate crisis. The administration wants more control of private land because of the climate crisis. Thus, they gain more control over us.

EO 14008 is unconstitutional because it goes against the Necessary and Proper Clause, Property Clause, and Enclave Clause in the Constitution. These provisions for federal land ownership protect the functions of state rights and promote individual freedom. The President has no authority to issue or execute this order.

Its wording is vague, providing few if any details or definitions. The terms "conserve" and "permanently protected" are used over and over but never defined, nor are procedures outlined. This is done purposely to keep the US citizens in the dark about the procedures.

# LAND GRAB

The UN has encouraged nations to adopt the plan to conserve and protect land in the name of climate change, continually increasing the percentage. Now it is at 70%. In section 216 of the EO titled Conserving Our Nation's Land and Water, our federal government intends to advance the international agenda of permanently preserving 30% of the world's lands and oceans by 2030. Then acquire another 20% by 2050. Based on these resolutions the UN and governments want to control most of the land and want individuals to move to urban areas.

The EO stresses that based on science and the urgency of time we must start immediately to reverse manmade climate change and protect the ecosystem and wildlife by permanently protecting 30% of the land in a natural state. However, the scientific basis and references in the EO cite press releases and opinion papers, not data.

For instance, based on a Department of Interior fact sheet issued on 1/27/21, the US is losing football size area (1.32 acres) to development every second, which threatens our land and wildlife. Norma James, a natural resource attorney, calculated if 3000 acres per day are lost that equals 1.1 million acres per year, or 11 million acres per decade. The US has 2.27 billion acres and 11 million acres represent just .05% of the land. So how does 11 million acres play into the 30% of 2.27 billion acres? The amount of land developed over the years will be nothing when compared to the land grab the federal government plans.

On August 25, 2021, our governor, Michelle Lujan Grisham, followed in the footsteps of the President by signing Executive Order 2021-052, protecting New Mexico's Lands, Watersheds, Wildlife and Natural Heritage. The Governor sets the goal of 30% to be conserved by 2030 and an additional 20% by 2050. She established a 30x30 committee of 7 departments, and divisions to review and utilizes resources, fund and establish programs to accomplish this land grab. No private landowners are included on the committee. Thus, the State is saying they know what is best for the NM citizens.

Since neither of the Executive Orders define conservation or land protection and the Department of Interior's fact sheet references the 12% (289 million acres) of US permanently protected land in its natural state, it can be assumed the goal is to increase this to 30% by 2030.

The term "permanently protected land in its natural state" means land set aside permanently and off limits to most human use. The 12% cited is comprised of national parks, wilderness areas, private lands with permanent conservation easements, state parks, national wildlife refuges, national monuments, and other protected areas.



*Where are we heading?*





Approximately 60% of the US' 2.27 billion acres are in a natural state. The Federal Government owns 28% (640 million acres). 92% is in the 12 Western states. Thus, to meet the percentage goals and deadlines of 2030 and 2050, the government must do a land grab. The EO 14008 states that the Secretaries of the Interior, Agriculture, Commerce, and other environmental agencies will solicit input from State, local, Tribal, territorial officials, agricultural and forest landowners, fishermen and other key people to identify strategies and steps to gain broad participation in their goal.

Why are hunters not mentioned? The Trump administration issued Order 13792 allowing states and local communities veto power of federal land acquisition in their jurisdiction. On Feb 11, 2021, the acting secretary of interior, Scott de la Vega, revoked this. Now local and state communities have neither say nor veto power over land acquisition by the federal government.

Because of the failures of the federal and state governments in domestic and foreign situations, Americans have lost faith and trust. The Federal government has been a poor steward of the land as proven over a century of mismanagement which resulted in the recent wildfires. This program denies our private property right. The unintended consequences will lead to a reduction in food and animal production and an increase in individual taxes.

So, what can the average citizen do to prevent this land grab? Get involved, study the issues, join American Stewards or other such organizations, help inform others, and let your voices be heard by your vote and political action. Work to save our Constitutional Republic.

## The Awakened Must Rescue the Nation from the Woke

Unless you're living in a cave, you are no doubt aware of the FBI raid on Mar-a-Lago and its implications. It's one thing for Joe Biden to punish his political enemy; it's another for dozens - if not hundreds - of public servants (and the media) to engage in Stasi tactics. But if you think only President Trump and associates will suffer that kind of abuse, here are examples closer to home.

The Pacific Justice Institute, a legal organization which supports - at no cost - families, religious organizations and businesses, is raising money for two specific, jaw-dropping causes - both of which are largely under the radar of Californians and the rest of the country. PJI opposed California SB107, a bill amended by renowned gay activist and California senator Scott Wiener. This bill encourages troubled parents who lose custody in conservative states like Texas to take the child in violation of court orders and fly to California. And, if a child runs to California in search of "gender affirming healthcare", California will not send the child back to the parents and will provide the "care."

Here's one section of the bill's text:

*The bill would prohibit the enforcement of an order based on another state's law authorizing a child to be removed from their parent or guardian based on that parent or guardian allowing their child to receive gender-affirming health care or gender-affirming mental health care. The bill would prohibit a court from finding that it is an inconvenient forum where the law or policy of another state that may take jurisdiction limits the ability of a parent to obtain gender-affirming health care or gender-affirming mental health care, as defined, and the provision of such care is at issue in the case before the court. The bill would authorize a court to take temporary jurisdiction because a child has been unable to obtain gender-affirming health care. The bill would additionally prohibit a court from considering the taking or retention of a child from a person who has legal custody of the child, if the taking or retention was for obtaining gender-affirming health care or mental health care.*

I include the text to demonstrate how many rights the bill violates: parents have no rights and states have no authority, only California. Since all states must agree with California law or California will keep their children, there are no states' rights. Most importantly, California is encouraging children not old enough to vote or drink - vulnerable children whose brains are not done growing - to leave their homes, mutilate their bodies and take hormones without thought to their future mental or physical health.



The second matter from Pacific Justice Institute involves the California Child Care Act, in which "almost every preschool in California, including daycare ministries in churches [is] to be defined as a daycare center." Once defined, "the church ministry is subject to state regulation – a host of restrictive protocols and woke rules by the department of social services." "Basically, to run a daycare ministry in California, a church has to forfeit First, Fourth, Fifth, Sixth, Seventh and Fourteenth Amendment rights." So, say goodbye to required participation in prayer. Hello unlawful search and seizure when state authorities enter unannounced. The state can interview children without parental consent and employees without reading them their Miranda rights. Churches also lose the right to a trial by jury and the right to face their accuser.

Notice how constitutional rights get stripped away in thin slices within obscure laws that the conspiratorial media never reports to the public. Even if reported, recent generations with little education about the Constitution don't know what rights are being lost. Anyone unaware they are in conflict with this new system will get blindsided.

On a personal front a few days ago, a friend, who describes herself as a "letter writer," had just dashed off complaints to Joe Biden and the DOJ re: the Mar-a-Lago raid.

Not 48 hours later, and 24 after the IRS announced hiring 87,000 new employees, she heard a knock on her door. Three IRS employees, one of them large, burly and built, demanded to see her husband, who wasn't home. The couple had received neither letter, nor a call announcing the IRS visit, and it took three requests to get them to show ID. My friend handled it brilliantly, requesting they make an appointment first with their accountant and then with the couple. But the point is the IRS were clearly harassing her, and most likely because of their political views.

If it wasn't clear before, we're in a cold civil war, and our side must win. To paraphrase Winston Churchill's "Fight on the Beaches" speech: we shall and must go onto the end, we shall fight at the polls, we shall fight in the churches, we shall fight in the daycare centers, schools and schools boards. We shall fight in the courts and push back on social media. We shall wake up our family, friends and neighbors, until in God's good time, the awakened step forth to rescue the nation from the woke.
